ADDENDUM

NOTICE OF EXPRESSION OF INTEREST (REQUEST FOR PRE-QUALIFICATION) UNDER OPEN BIDDING

This is an Addendum to the original adverts published by Kyambogo University in the New Vision Newspaper on 1st August 2024 and in the East African Newspaper on 3rd August 2024 inviting interested and competent companies to submit Request for Qualifications to design, build, finance and operate the listed infrastructure projects.

The purpose of this addendum is to:

- (a) **Inform the prospective bidders that the projects shall not be split into lots as earlier indicated. The two projects are therefore as follows:**

Project 1: Students Accommodation

The Student's Accommodation project aims to provide high-quality accommodation facilities with a capacity of 10,000 beds. This project consists of modern, high-quality sustainable facilities that will provide students with comfortable and safe living spaces on campus. The project will include the provision of amenities such as study areas, common rooms, recreational and sanitary facilities, shared kitchen and dining areas, and others necessary for enhancing the student's overall learning experiences.

Project 2: Multi-Purpose Sports Complex and a Business Centre

The Multipurpose Sports Complex (5,000 seating capacity) will provide state-of-the-art facilities for various sports disciplines while the Business Centre will offer commercial and office rental space, meeting rooms, shops, restaurants, and other appropriate amenities to support the University and neighbouring community.

Note Bidders are free to express their interest in either Project 1, Project 2 or both.*

(b) **Application for Pre-qualification documents**

Interested and competent companies with capability to design, build, finance and operate the project(s) should submit a letter requesting for a pre-qualification document by sending an email to pppprojectofficer@kvu.ac.ug by 5:00 PM EAT (East Africa Time) on **13th September 2024** specifying which project they are applying for. The request shall include the following information: company name, contact person(s), contact details (email, telephone, and physical address). Alternatively, applicants can deliver their written application letters and pick the documents from the physical address indicated in the table in section (c) of this advert.

(c) **Submission of Expression of Interest**
