

## NOTICE OF REQUEST FOR PRE-QUALIFICATION

Development of Green Inclusive Multi-Purpose Resource Centre Project Under Open Bidding Method in accordance with the PPP Act 2015 and PPP Regulations 2019

Arua City Council in collaboration with United Nations Capital Development Fund (UNCDF) intends to involve private sector partners in the development of the Green Inclusive Multi-Purpose Resource Centre project using the Public Private Partnership (PPP) arrangement in accordance with the PPP Act, 2015.

## **Project Description**

The Green Inclusive Multi-Purpose Resource Centre will comprise of a youth skilling centre, information hub, modern library, banking facilities, shops, pharmacies, Clinics, leisure and office spaces for companies and the business community. This, however, does not limit the private sector from introducing further innovations to make the project more bankable.

Arua City Council is providing 0.593 acres of its 1.687 Acres land on main street, adjacent to the Office of the Prime Minister and opposite Total Petrol Station, for this project as its contribution, while UNCDF has provided grant funding to the City Council, that will be used as its additional contribution to the project. Depending on the capacity of the private sector, the proposed innovations to increase return on investment, the city is willing to make available, the entire 1.687 acres for this project.

## **Request for Pre-qualification documents**

Interested and competent companies with the capability to design, build, finance and operate the Green Inclusive Multi-Purpose Resource Centre are required to pay **Uganda Shillings 200,000/=** (Two Hundred Thousand) only in order to receive the Request for Pre-qualification.


## **Bid Submission**
